Any entries withdrawn after 6 pm on March 23, 2018, will be replaced by a wait listed entry if any are available. A full refund will be issued for withdrawn entry if replaced by a wait listed entry.

Any wait listed entry that does not move off the wait list into the trial by 6pm on March 28,2018, will receive a full refund. After that time, no entries will be accepted, cancelled, altered or substituted.

**HEIGHT DIVISIONS**

Owners/agents are responsible for entering the proper height divisions. All height divisions will be offered in both the standard classes and the jumpers with weaves classes.

**Regular-class** exhibitors may choose to enter their dog in a higher height division than required by AKC, but not in a height division lower than the AKC mandated height. **Preferred** exhibitors are required to jump in their proper height division.

## COURSE FAMILIARIZATION

Handlers in all classes are permitted to walk the course, without a dog, during a walk-through period held prior to the start of the class. The walk-through is restricted to handlers entered in that class only.

A warm-up area, consisting of a regulation agility jump, will be provided for exhibitors. The warm-up area is to be used exclusively for warming up the dog and not for training the dog.

## OBSTACLES AND RING CONDITIONS

Obstacles will meet the specifications for obstacles in the current edition of the AKC Regulations for Agility Trials. M.A.D. Agility's equipment is within all specs to AKC requirements. Weave poles are 24" spaced and contacts rubberized. Ring sizes will be 90' x 100' for all 3 rings.

Please consult the AKC Regulations for Agility Trials for a complete description and eligibility for entry into these classes. The exhibitor is fully responsible for entering the dog in the correct class(es)/height divisions. Dogs running in a lower height division than they are eligible for will be eliminated.

## MOVE UPS

Per American Kennel Club Regulations for Agility Trials, dogs may be moved up to a higher class, at the request of the owner, as a result of qualifying for an agility title. Before the trial, move-ups may be made prior to the move-up deadline via email to [scoresmore@verizon.net](mailto:scoresmore@verizon.net) or USPS in writing to Bonnie Reifsnyder, 250 Trail Rd., Hershey, PA 17033. Verbal move-ups will not be accepted. Move-ups are due in writing by Monday, April 9, 2018 at 6pm.

Day-to Day Move-ups are only allowed for dogs entered at the set of back-to-back agility trials for succeeding days of that set of back-to-back agility trials. Move-ups must be submitted in writing at the trial within 15 minutes of the last run of the trial day for the following day(s) and cannot be conveyed via fax, email, phone or verbally. They must be given to Trial Secretary. Forms will be available in the MOVE-UP BOOK that will be located near score postings.

## EXHIBITOR INFORMATION

**Tarps are to be used under all crates.**

### SAFETY, BEHAVIOR and LIABILITY

The safety of the dog is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial committee, be asked to leave the show site. In such case, no refund of any fees paid will be made. DDTC , Scores-N-More & In The Net and its agents, employees, etc., will assume no responsibilities for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children. DDTC reserve the right to decline entries for cause and may remove any dog on account of aggression. No one shall have any recourse or claim against the DDTC or any official thereof.

All dogs must be on leash attached to their handler at all times when on trial grounds except when in the designated warm-up area or competing on the course.

All regulations governing the use of this facility, and all regulations and decisions of the trial committee at this trial will be strictly enforced, including and not limited to the recorded information of this premium list. Puppies under 4 months of age are prohibited at AKC Agility Trials.

**DDTC does not agree to arbitrate claims as set forth on the Official AKC entry form for this event.**

### ENTRY ELIGIBILITY

This trial is open to all dogs fifteen (15) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number (in trials offering mixed breed entries), or approved Foundation Stock Service (FSS) breeds are eligible to participate.

Dogs with a Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number (in trials allowing mixed breed entries) must be spayed or neutered in order to compete. Wherever the word "dog" is used in these regulations it includes both sexes.

Dogs should be physically sound. Dogs that are blind shall not be eligible, and neither are bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect the dog's physical or mental performance. No dog shall compete if it is taped or bandaged in any way or has anything attached to it for medical purposes. Refer to Chapter 2 of the Registration and Discipline Rules for the listing of registerable breeds that may participate.

### REFUNDS

No entry will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy or any other cause beyond the control of the organizing committee. No entry fee will be refunded in the event a dog is absent, disqualified, excused or barred from competition by the action of the event committee.

Refunds for Bitches in Season / injured dogs/ injured handlers: A refund of entries minus a DDTC service fee of \$10.00 / dog/ day for bitches in season or injured dogs will be granted when a veterinarian's letter is presented as proof to the Trial Secretary prior to the start of the 1<sup>st</sup> trial day dog is entered. Must use official Veterinary's Letter Head. Official Doctor's Letter Head must be used in the case of an injured handler.

### Leashes

All dogs must be on leash at the trial. Retractable leashes are not allowed in the building. Dogs may only be off leash while running the course or at the practice jump.

**EMAILED MOVEUPS:** When emailing a moveup to us please just give the following information. TRIAL NAME, Owner Name, Dog Call Name, Move up for what days (Saturday, Sunday, etc.), Moving from, Moving to (PLEASE include STD, JWW, or FAST).

**NOVICE MOVEUPS:** Dogs or Handlers having attained ANY AKC Agility Title (Std, JWW, OR FAST class) **must be moved to the Nov B Classes** (Std, JWW and FAST classes). PLEASE LET US KNOW AS SOON AS YOU REALISE THAT A CHANGE IS NEED. Once we print all the trial paperwork on Tuesday before the trial, it is a much bigger problem to fix. This request must be made in writing at least 30 minutes before the start of the trial. This request must state the reason and justification for the change from Novice A to Novice B. The dog can also be moved up a level (Nov to Open) at the request of the owner subject to the normal move-up criteria.
